I. INTRODUCTION

I.I Purpose of this Memorandum

The Indiana Department of Transportation (INDOT) is initiating ProPEL Indy, a Planning and Environment Linkages (PEL) study on Interstate 65 (I-65) and I-70 inside the I-465 Loop in Indianapolis, Indiana. Analysis and planning activities will be conducted in coordination with resource agencies, stakeholders, and the public. Transportation planning products from the PEL process will shape and inform subsequent project-specific environmental reviews conducted in accordance with the National Environmental Policy Act (NEPA).

As part of the data-gathering phase of these studies, the Memorandum's purpose is to collect information on previously identified above-ground cultural resources that are listed in the National Register of Historic Places (NRHP) or may be potentially eligible for listing in the NRHP.

This identification is a planning tool to help inform INDOT and appropriate stakeholders of cultural resources along the ProPEL Indy corridor. Specifically, any improvement projects that develop with federal involvement as a result of this PEL study must comply with Section 106 of the National Historic Preservation Act (NHPA) and its implementing regulations under 36 CFR Part 800. Under Section 106, federal agencies must identify and assess the effects of their actions on those cultural resources that are listed in or eligible for listing in the NRHP and seek ways to avoid, minimize, and/or mitigate adverse effects. The data collected for the ProPEL Indy study will help identify any properties currently listed in the NRHP and those that have the potential to be eligible for listing in the NRHP based on previous surveys. Formal determinations of NRHP eligibility will occur in the future in the Section 106 process for any federally funded or approved project programmed from the ProPEL Indy study.

1.2 Study Limits

The ProPEL Indy study limits include approximately 11 miles of I-65, 14 miles of I-70, and 1 mile where I-65 and I-70 overlap. The study limits are broken into the following four "spokes" as an organizational tool (see Figure 1):

• **65 Spoke** – From the I-465/I-65 interchange on the northwest side to the 21st Street interchange

- **65/70 Downtown Spoke** I-65 from the 21st Street interchange south to Alabama Street (west end of North Split project), I-65/I-70 from Washington Street (south end of North Split project) south to the South Split interchange, and I-70 from just west of West Street interchange east to the South Split interchange
- **70 West (W) Spoke** From the I-465/I-70 interchange on the west side to just west of the West Street interchange
- **70 East (E) Spoke** From just west of the Keystone Avenue/Rural Street interchange (east end of North Split project) to the I-465/I-70 interchange on the east side

The study limits extend slightly beyond I-465 and the I-65/I-70 South Split interchange to consider the potential influence of those system interchanges. Two active federally funded projects under construction (I-65/I-70 North Split) or in NEPA (I-65 Safety and Efficiency) are largely excluded from the study limits. ProPEL Indy's study area does overlap with the I-65 Safety and Efficiency project on the southeast side of Indianapolis. The overlap with I-65 Safety and Efficiency extends from north of Fletcher Ave on I-65/I-70 to the South Split interchange ending south of Morris Street along I-65. The remainder of the I-65 Safety and Efficiency project area, which extends south on I-65 to I-465 is excluded from the study limits..

The built environment along the ProPEL Indy corridors primarily consists of urban development with mixed residential, commercial, and industrial uses, but also includes suburban areas, particularly along the 65 Spoke to the northwest.

2. CULTURAL RESOURCES IDENTIFICATION

2.1 Methodology

For the purposes of this PEL study, a boundary of 0.50 mile from each side of the I-65 and I-70 centerlines was delineated. Within this boundary, a desktop survey and literature review of previously identified eligible, potentially eligible, or listed above-ground resources were conducted.

The primary resource referenced for this study was the Indiana Historic Buildings, Bridges, and Cemeteries (IHBBC) Map (Indiana Department of Natural Resources, Division of Historic Preservation and Archaeology [IDNR, DHPA] 2023). The IHBBC Map is a database containing

information about above-ground cultural resources in the state and is maintained by the IDNR, DHPA. The IHBBC Map includes data from the Indiana Historic Sites and Structures Inventory (IHSSI) County Interim Reports, which document countywide surveys to identify potentially historic sites and structures. In Marion County, the surveys were conducted and reported at the township level. The most recent IHSSI interim reports for Marion County were developed between 1991 and 1994. It is possible additional properties in these townships are now old enough to be considered potentially historic. In addition, the INDOT-Cultural Resources Office's (INDOT-CRO's) Public Web Map was examined to identify any above-ground cultural resources that have been determined eligible for listing in the NRHP as a result of Section 106 coordination between INDOT-CRO and the Indiana State Historic Preservation Office (SHPO).

For the purposes of the PEL study, the resources mapped and recorded via the IHBBC Map include the following:

- Properties listed as National Historic Landmarks (NHL), properties listed in the NRHP, and properties listed in the Indiana Register of Historic Sites and Structures (Indiana Register);
- Properties rated as Outstanding or Notable in the IHSSI; and
- · Historic bridges.

The historic bridges mapped on the IHBBC Map were cross-checked with Volume 2 of the *Indiana Historic Bridge Inventory* (M&H Architecture, Inc. 2009).

In addition, MapIndy and Google Maps were examined to determine whether previously recorded resources remain extant within the study area. Although efforts were made to determine whether NRHP and IHSSI properties are still extant, no effort was made to further gauge the current integrity of any such properties.

Properties built after World War II (WWII) were likely not identified in IHSSI surveys. Therefore, there are likely post-WWII resources that have not been surveyed in a meaningful way along the corridor. County parcel data was examined as a means to identify post-WWII above-ground resources not included in IHSSI surveys. This information is presented on Figure 3.

2.2 Caveats

Several factors should be considered in interpreting the data presented as part of the ProPEL Indy study:

- No fieldwork or windshield reconnaissance was conducted. The resources identified were done through a desktop survey and data obtained from the sources cited above.
- The IHSSI ratings are indicators of potential NRHP eligibility. However, formal NRHP
 evaluations that would occur with Section 106 projects including research, analysis, and
 contextual comparison are not provided in this study. Properties rated "Contributing" or
 not previously surveyed could later be found to be NRHP eligible and conversely those
 rated "Notable" or "Outstanding" may be determined not eligible.

2.3 Identification Results by Type

Examination of the INDOT-CRO's Public Web Map identified two historic districts determined eligible for listing in the NRHP. A small portion of the Windsor Park Historic District falls within the study area for the 70 E Spoke. The Windsor Park Historic District was determined eligible for listing in the NRHP through Section 106 coordination for the North Split project (INDOT Des. Nos. 1592385 and 1600808). The Green Hills Historic District is located within the study area for the 65 Spoke. The historic district was identified through a SHPO study of post-WWII residential subdivisions. Although not shown on the INDOT-CRO's Public Web Map, a third historic district, the St. Patrick Catholic Church Historic District, was determined eligible for inclusion in the NRHP through Section 106 coordination for the I-65 Safety & Efficiency project (INDOT Des. No. 1400073). This historic district is located in the 65/70 Downtown Spoke.

2.3.1 National Register of Historic Places (NRHP)

Three NHLs are located in the study area; these resources are shaded blue in Table 1. The Indiana World War Memorial Plaza Historic District, the Benjamin Harrison House, and the James Whitcomb Riley House are all located in the study area for the 65/70 Downtown Spoke.

In addition to the two historic districts that have been determined eligible for the NRHP, 20 historic districts are listed in the NRHP and/or the Indiana Register (Table 1). One historic district, the Indiana World War Memorial Plaza Historic District, is an NHL. The Holy Cross-Westminster Historic District is listed in the Indiana Register, but was determined eligible for inclusion in the NRHP as part of Section 106 coordination the North Split project (INDOT Des. Nos. 1592385 and 1600808). Most of the historic districts are in the study area for the 65/70 Downtown Spoke; however, some cross into more than one spoke.

In addition to the two individually-listed NHLs, there are 62 resources individually listed in the NRHP, most of which are in the study area for the 65/70 Downtown Spoke (Table 1). Five resources, not included in the above count, have been delisted from the NRHP and/or

demolished; these are shaded orange in Table 1. Thirteen resources are listed solely in the Indiana Register, nine of which are listed under an Indianapolis Auto Industry Thematic Resources study. A tenth Indiana Register-listed auto industry thematic resource has been demolished.

2.3.2 Indiana Historic Sites and Structures Inventory (IHSSI)

Table 2 lists the resources rated Outstanding or Notable on the IHBBC Map. Of the Outstanding-rated resources, 135 remain extant and 6 were identified as being no longer extant. Many of the Outstanding-rated resources are listed in the NRHP or contribute to NRHP-listed historic districts. A few have been determined eligible for inclusion in the NRHP through Section 106 coordination for previous projects. The majority of the Outstanding-rated resources are located in the study area of the 65/70 Downtown Spoke.

A similar number of Notable-rated resources were identified: 135 extant and 4 no-longer-extant. Many contribute to NRHP-listed historic districts, and a few are individually listed in the NRHP or have been determined eligible for inclusion in the NRHP through Section 106 coordination for previous projects. As with the Outstanding-rated resources, the Notable-rated resources are mostly found in the 65/70 Downtown Spoke.

3. BUILDING DATES BY PARCEL

ASC Group, Inc. has compiled construction dates for buildings within the study area by parcel. The purpose of compiling this data is to aid in the identification of post-WWII properties and subdivisions that may not have been previously surveyed. The dates were obtained from the 2022 Geographic Information System (GIS) Data Harvest Program (https://ingov.maps.arcgis.com/apps/dashboards/a2268a22b8764c9eadca1fe32dfa25e9).

The 2022 GIS Data Harvest Program was accessed to include parcel information and approximate property ages in part to help aid in the identification of post-WWII properties and subdivisions that may not have been previously surveyed. In some instances, parcel data was absent where structures were present. Maps depicting the parcel age ranges (where available) in the study area are included on Figure 3.

4. CONCLUSION






Figure 2 **Above-ground**

For the ProPEL Indy study, ASC Group, Inc., identified 407 above-ground resources that are listed in or potentially eligible for listing in the NRHP. Three NHLs and 105 NRHP-listed resources are within the study corridor. Additional Outstanding and Notable-rated resources in the ProPEL Indy study area not already listed individually or as a contributing resource in a historic district are potentially eligible. This identification is intended as a planning tool and is not a final determination of NRHP eligibility. Any federally funded or approved project that is programmed as a result of the PEL study will follow the Section 106 process, during which time cultural resources will be formally evaluated for NRHP eligibility. The results of the ProPEL Indy study above-ground resources identification are shown in the included Figures 2 and 3 and Tables 1–4.
